

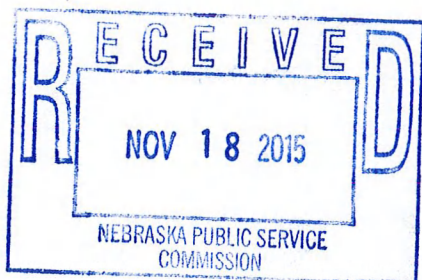

**MOTION TO DISMISS WITHOUT
PREJUDICE THE APPLICATION
FOR APPROVAL UNDER THE
MAJOR OIL PIPELINE SITING ACT**

COMES NOW the Applicant TransCanada Keystone Pipeline, LP (“Keystone”) and pursuant to the Major Oil Pipeline Siting Act and regulations promulgated thereunder, to request that its Application for Approval filed on October 5, 2015, be dismissed without prejudice to refiling. In support of this motion, Keystone states that on Friday, November 6, 2015, the United States Department of State issued a Record of Decision of National Interest Determination with regard to Keystone’s Application for a presidential permit in which Keystone’s application was denied. Keystone is assessing the impact of the denial on the aspects of the pipeline within the United States, including its pending Application for Route Approval to the Public Service Commission (“Commission”). In light of the time requirements under the Major Pipeline Oil Siting Act for a Commission decision, Keystone is requesting its pending Application be dismissed without prejudice. Keystone reserves the right to refile its Application for Route Approval with the Public Service Commission at an appropriate time.
